The remaining charges (\$15 per child, minimum of 10 children plus any extra party time charge) will be due in full the day of the party. Payments can be made by cash, checks (payable to Winonah School of Cosmetology), and credit cards.

**Winonah's** will provide private use of our classroom for our basic party fee that covers two hours of party time. You may reserve extra party time for additional charge. You will have access to the birthday party room 15 minutes prior to guest arrival.
